1 WHEREAS, According to the American Cancer Society, with

2 the exception of skin cancer, breast cancer is the most commonly

3 diagnosed cancer among American women; and

4 WHEREAS, Breast cancer is second only to lung cancer as the 5 leading cause of cancer-related deaths among women; and

6 WHEREAS, Approximately 24,985 women and 200 men are

7 diagnosed with breast cancer in California each year, and

8 approximately 4,280 women and 35 men die of the disease; and

1 WHEREAS, The number of women who die of breast cancer 2 each year in California constitutes one-tenth of the number of 2 women who die of breast senser in the United States, and

3 women who die of breast cancer in the United States; and

4 WHEREAS, The chance of a woman having invasive breast 5 cancer in her lifetime is about 1 in 8, and the chance of dying from 6 breast cancer is about 1 in 36; and

7 WHEREAS, The risk of getting breast cancer increases with 8 age; and

9 WHEREAS, Earlier detection of breast cancer through 10 mammography and self-examination increases chances of 11 successful treatment; and

WHEREAS, With early detection and proper treatment, the five-year relative survival rate for breast cancer has increased from P2 percent in the 1940s to 89.2 percent today. However, once the cancer spreads beyond the breast, the survival rate drops to a mere percent even with modern treatments and technologies; and

 Services Task Force recommends that women between 50 and 74

<u>STOP</u> SCR 15 from Further Consideration (An Unpopular, Spurious Resolution without Merit)

SCR 15 is another misguided and unnecessary defacto endorsement of cruelty and exploitation of animals.¹ We urge the ASM Rules Committee to not allow it to move any further. It is a disingenuous attempt to glorify and legitimize inhumane, abusive treatment of animals and is an embarrassment to the integrity of all Assembly members—let alone the citizens of California.

SCR 15 is not content to focus on ranch hands and their daily valid activities. Instead, it hides behind legitimate ranching and surreptitiously glamorizes the term "cowboy" by trying to associate it with ranchers, in order to gain undeserved support for rodeos. In a desperate attempt to garner wider support for this disgraceful resolution, firearms enthusiasts and women are tacked on to the list as well.

SCR 15 is a flawed effort to counter mounting evidence that the general public abhors animal cruelty and rejects animal exploitation—especially rodeo's abject abuse. In fact, rodeo is banned in many communities across the nation and in other countries. Many who attend a rodeo not only never attend again, but also detest the bullying and cruel activities they observe first hand. Additionally, SCR 15, as similar measures before it, blindly subscribes to the false claims made by rodeo promoters, such as:

SCR 15 Claim	Reality and Truth
"Pioneering men and women, known as cowboys"; and "transcends genderpolitical affiliation;"	Men and women who settled/established American's frontiers were farmers and ranchers. As a heavily chauvinistic industry, women and minorities were and are not mainstream; politically, cowboy activities, such as rodeos, are often extremist; and religiously it's borderline fanatic.
"cowboy spirit exemplifies patriotism"	There is no justification or evidence that a cowboy "spirit exemplifies patriotism," other than trite and endlessly repeated self-serving, meaningless claims to that effect.
"cowboy is an excellent steward of the land and its creatures;"	SCR 15 mixes legitimate farming and ranching practices with unacceptable "cowboy" lifestyle activities. Multiple videos document and provide evidence of gross mistreatment of "creatures" in rodeo events by "cowboys." In addition to rodeo's

	exceptionally cruel timed calf roping events—snapping a calf's neck at the end of a rope—"throw away" calves are used in remote areas for endless hours of calf-roping practice. Injuries are ignored, and death is the norm. When all activities and elements are considered, any claims that cowboys are an "excellent steward of creatures" is blatantly false.
"Code of Conduct"	From attempts to hide illegal electronic shocking of animals in chutes, to tail and ear twisting, wire poking, and so much worse (see <u>www.rodeocruelty.com</u>), personal integrity is not a high priority with cowboys.
"traditionunique element of American heritage"	Cowboy and cowgirl traditions are fabrications, beginning with Wild West Shows—and not American heritage. Horses were gentled and "broke" to not buck. They were never flank-strapped, spurred for an eight-second ride for the "show," or electronically shocked for enhanced "performances" on ranches. Neither were bulls ridden on ranches, yet SCR 15 erroneously insists it's American tradition. Rodeo's origins are Spanish—not American. Rodeo meant "round up," where ranchers' cattle herds were mixed on the plains and had to be separated. American rodeo "tradition" is a spin that perpetuates abject cruelty in "wild-west" type "shows" for greed and profit.
"Membership and participationcontinue to expand"	Simply not true. As the public becomes more aware of "cowboy" and rodeo cruelty, and its similarity to animal exploitation such as circuses, animal fighting, etc., outrage and opposition is what is expanding —not support for the abuse.

We urge Assembly Rules Committee members to (1) recognize this despicable sham for what it is; and (2) take the moral high road and not approve this or similar shameless resolutions. The Rules Committee provides a legitimate standard that must be met before subjecting the entire Assembly to an embarrassing floor vote. Any bogus resolution that attempts to glamorize others who torment and exploit animals for profit, and/or promote or participate in cruel and abusive activities (that can and do cause injuries and death) should never be recognized by the State of California.

We urge members of the ASM Rules Committee to recognize SCR 15 as being a misguided, factually erroneous, misleading, and unnecessary resolution with no redeeming values. As such, it is a disgrace to citizens of the state of California and must be stopped.

We urge a strong NO vote on SCR 15.
