LEGISLATIVE COUNSEL’S DIGEST

ACR 101, as introduced, Brough. Coastal Cleanup Day.

This measure would encourage citizens, businesses, groups, organizations, and public institutions to observe and participate in coastal protection activities, and proclaim September 19, 2015, as the 31st annual Coastal Cleanup Day.

Fiscal committee: no.

- 1 WHEREAS, The State of California has 1,100 miles of coastline,
2 including many sandy beaches, rocky shores, bluffs, estuaries,
3 marshes, tidal flats, urban areas, and harbors; and
4 WHEREAS, The natural resources of the coastal zone are among
5 California’s most important economic and environmental resources;
6 and
7 WHEREAS, The marine environment is one of the most valuable
8 resources for recreation, tourism, fishing, and other coastal
9 industries; and
10 WHEREAS, The State of California is strongly committed to
11 thoughtful management of the state’s coastline to ensure that the
12 environmental and economic value of the coastal zone will be
13 sustained; and

1 WHEREAS, Preserving the productivity and quality of coastal
2 resources requires public awareness, support, and an understanding
3 that protection of the coast is a responsibility shared by individual
4 citizens, the business community, and public institutions; and

5 WHEREAS, The California Coastal Commission has been the
6 primary sponsor of Coastal Cleanup Day since 1985; and

7 WHEREAS, Coastal Cleanup Day is the largest annual volunteer
8 event in the state, with over 60 coordinating organizations and
9 70,000 volunteers participating; and

10 WHEREAS, Over 1.3 million Coastal Cleanup Day volunteers
11 have collected over 21,000,000 pounds (10,500 tons) of trash from
12 California's beaches, shoreline, creeks, estuaries, and the ocean
13 floor over the last 30 years; and

14 WHEREAS, The 31st annual Coastal Cleanup Day will be held
15 on September 19, 2015; now, therefore, be it

16 *Resolved by the Assembly of the State of California, the Senate*
17 *thereof concurring*, That the Legislature recognizes the 3rd
18 Saturday in September as Coastal Cleanup Day and encourages
19 individual citizens, businesses, groups, organizations, and public
20 institutions to observe Coastal Cleanup Day this year and every
21 year, and to participate in appropriate activities designed to promote
22 a healthy and productive coastal environment for the benefit of
23 the people of California and the nation, and hereby proclaims
24 September 19, 2015, as the 31st annual Coastal Cleanup Day in
25 California; and be it further

- 3) The natural resources of the coastal zone are among California's most important economic and environmental resources and the marine environment is on the most valuable resources for recreation, tourism, fishing, and other coastal industries.
- 4) Coastal Cleanup Day is the largest annual volunteer event in the state, with over 60 coordinating organizations and 70,000 volunteers participating. Over 1.3 million Coastal Cleanup Day volunteers have collected over 21,000,000 pounds (10,500 tons) of trash from California's beaches, shoreline, creeks, estuaries, and the ocean floor over the last 30 years.
- 5) The State of California is strongly committed to thoughtful management of the state's coastline to ensure that the environmental and economic value of the coastal zone will be sustained.

LEGISLATIVE COUNSEL’S DIGEST

ACR 102, as introduced, Salas. Red Ribbon Week.

This measure would proclaim October 23 to October 31, 2015, inclusive, as Red Ribbon Week, and would encourage all Californians to help build drug-free communities and participate in drug prevention activities.

1 WHEREAS, Californians for Drug-Free Youth, Inc. (CADFY),
2 a statewide parent-community organization, the office of the
3 Governor, the office of the Attorney General, the State Department
4 of Education, the California Parent Teacher Association, and over
5 100 other statewide agencies, departments, and organizations have
6 been strong advocates for Red Ribbon Week; and
7 WHEREAS, The National Family Partnership, Inc., initiated
8 the Red Ribbon Campaign after Drug Enforcement Administration
9 Agent Enrique “Kiki” Camarena was killed in Mexico by drug
10 traffickers in 1985; and
11 WHEREAS, Parents, youths, schools, businesses, law
12 enforcement, religious institutions, service organizations, senior
13 citizens, medical and military personnel, sports teams, and others
14 concerned about the effects of drugs on our communities will

1 demonstrate their commitment to drug-free, healthy lifestyles by
2 wearing and displaying red ribbons during this weeklong
3 celebration; and

4 WHEREAS, The theme of this year's effort is "Respect
5 Yourself. Be Drug Free"; and

6 WHEREAS, Securing a safe and healthy future for our children
7 is directly threatened by drug abuse, and awareness of this problem
8 will help individuals in fighting drug abuse; and

9 WHEREAS, The objective of Red Ribbon Week 2015 will be
10 to promote this view through drug prevention, education, parental
11 involvement, and communitywide support; and

12 WHEREAS, The Assembly of the State of California has further
13 committed its resources to ensure the success of the Red Ribbon
14 Week celebration; now, therefore, be it

15 *Resolved by the Assembly of the State of California, the Senate*
16 *thereof concurring*, That the Legislature hereby proclaims its
17 support for the Red Ribbon Week celebration by proclaiming the
18 period of October 23 to 31, 2015, inclusive, as Red Ribbon Week;
19 and be it further

20 *Resolved*, That the Legislature encourages all Californians to
21 help build drug-free communities and to participate in drug
22 prevention activities by making a visible statement that we are
23 firmly committed to healthy, productive, and drug-free lifestyles;
24 and be it further

25 *Resolved*, That the Chief Clerk of the Assembly transmit copies
26 of this resolution to the Governor, and to the author for appropriate
27 distribution throughout the state.

SUMMARY: Proclaims October 23 to October 31, 2015, as Red Ribbon Week and would encourage all Californians to help build drug-free communities and participate in drug prevention activities. Specifically, **this resolution** makes the following legislative findings:

- 1) Californians for Drug-Free Youth, Inc. (CADFY), a statewide parent-community organization, the office of the Governor, the office of the Attorney General, the State Department of Alcohol and Drug Programs, the State Department of Education, the California Parent Teacher Association, and over 100 other agencies are cosponsoring October 23 to 31, 2015, inclusive, as the period that includes Red Ribbon Week.
- 2) Red Ribbon Week was initiated by the National Family Partnership, Inc., after Drug Enforcement Administration Agent Enrique "Kiki" Camarena was killed in Mexico by drug traffickers in 1985.
- 3) During Red Ribbon Week, parents, youths, schools, businesses, law enforcement, religious institutions, service organizations, senior citizens, medical and military personnel, sports teams, and others concerned about the effects of drugs on their communities will wear and display red ribbons during this weeklong celebration to show their commitment to a healthy, drug-free lifestyle.
- 4) The theme this year is "Respect Yourself. Be Drug Free;" and, securing a safe and healthy future for our children is directly threatened by drug abuse. Awareness of this problem will help individuals in fighting drug abuse while promoting education, drug prevention, and parental involvement.
