House Resolution No. 24—Relative to Schoolbus Driver Day.

1 WHEREAS, Traditionally, on the fourth Tuesday of April, the
2 people of California recognize all schoolbus drivers for their
3 continued and excellent services to the youth of the state, and these
4 drivers are deserving of special public recognition and the highest
5 commendations; and

6 WHEREAS, The California Association of School
7 Transportation Officials is a professional organization that
8 promotes safe pupil transportation and advocates for continued
9 high standards for California's schoolbus drivers; and

10 WHEREAS, The safety of our children rests in the hands of
11 trained schoolbus drivers for up to six or seven hours each
12 schoolday; and

13 WHEREAS, Personal time and energy are expended by
14 schoolbus drivers in their initial training, maintaining a current
15 license, perfecting their driving skills, and accruing added
16 knowledge of schoolbus laws through continuing education classes;
17 and

18 WHEREAS, Schoolbus drivers, through counseling and
19 disciplinary techniques, are sometimes asked to assist pupils in
20 appropriate interactive peer and adult behavior; and

21 WHEREAS, Schoolbus drivers often face natural and
22 unexpected hazards in the performance of their duties; and

1 WHEREAS, Schoolbus drivers exhibit patience and kindness
2 toward pupils, parents, and school staff in the performance of their
3 duties; and

4 WHEREAS, Schoolbus drivers consistently demonstrate an
5 awareness of, and direct attention to, the mechanical maintenance
6 of the schoolbus and safety conditions of the schoolbus routes;
7 and

8 WHEREAS, Many schoolbus drivers perform their services for
9 thousands and thousands of accident-free miles, year after year;
10 now, therefore, be it

11 *Resolved by the Assembly of the State of California*, That the
12 Assembly recognizes April 23, 2019, as Schoolbus Driver Day,
13 and commends schoolbus drivers for their continued and excellent
14 services to the youth of the State of California; and be it further

15 *Resolved*, That the Chief Clerk of the Assembly transmit copies

- 2) The safety of our children rests in the hands of trained schoolbus drivers each school day; and, the drivers expend energy and personal time during their initial training, maintaining a current license, perfecting their driving skills, and accruing added knowledge of schoolbus laws through continuing education classes.
- 3) Schoolbus drivers often face natural and unexpected hazards in the performance of their duties; and, through counseling and disciplinary techniques they are sometimes asked to assist pupils in appropriate interactive peer and adult behavior.
- 4) Schoolbus drivers consistently demonstrate an awareness of, and direct attention to, the mechanical maintenance of the schoolbus and safety conditions of the schoolbus routes as well as exhibit patience and kindness toward the pupils, parents, and school staff in the performance of their duties.

Senate Concurrent Resolution No. 20—Relative to Bleeding Disorders Awareness Month.

LEGISLATIVE COUNSEL’S DIGEST

SCR 20, as introduced, Pan. Bleeding Disorders Awareness Month. This measure would proclaim the month of March 2019 as Bleeding Disorders Awareness Month in the State of California.

1 WHEREAS, The Legislature is proud to proclaim March 2019
2 as Bleeding Disorders Awareness Month in this state; and
3 WHEREAS, Hemophilia is a rare genetic condition affecting at
4 least 4,000 people in California, and von Willebrand disease
5 impacts at least 360,000 people in California; and
6 WHEREAS, Without treatment, people with hemophilia and
7 other related bleeding disorders face frequent, spontaneous bleeding
8 episodes in their joints, causing swelling in the joints, muscles,
9 internal organs, and brain. Repeated bleeding episodes in the joints
10 result in chronic degenerative arthritic conditions, which often
11 lead to frequent hospitalizations, permanent disability, and chronic
12 pain. Bleeding episodes involving internal organs and the brain
13 can cause permanent damage, disability, and even death; and
14 WHEREAS, Many individuals with hemophilia became infected
15 with human immunodeficiency virus (HIV) and hepatitis C in the
16 1980s due to the contamination of the blood supply and blood
17 products; and

1 WHEREAS, With proper care and access to comprehensive
2 medical resources, persons with hemophilia and other related
3 bleeding disorders can control bleeding episodes and can lead
4 productive lives; and

5 WHEREAS, Visits to federally recognized hemophilia treatment
6 centers reduce morbidity and mortality significantly; and

7 WHEREAS, The State of California is committed to proper care
8 and treatment of children and adults with hemophilia and other
9 related bleeding disorders through previously enacted legislation;
10 and

11 WHEREAS, This awareness month will generate greater
12 understanding of not only hemophilia but all inheritable bleeding
13 disorders; and

14 WHEREAS, This awareness month will foster a greater sense
15 of community and shared purpose among all individuals with
16 inheritable bleeding disorders; and

17 WHEREAS, This awareness month will elevate the awareness
18 of, and engagement in, the inheritable bleeding disorders journey
19 beyond this community to the general public, enabling the
20 prevention of illness, unnecessary procedures, and disability; now,
21 therefore, be it

22 *Resolved by the Senate of the State of California, the Assembly*
23 *thereof concurring*, That the Legislature pause in its deliberations
24 to proudly proclaim the month of March 2019 as Bleeding
25 Disorders Awareness Month in the State of California; and be it
26 further

27 Resolved, That the Secretary of the Senate transmit copies of

SUBJECT: Bleeding Disorders Awareness Month.

SUMMARY: Proclaims the month of March 2019 as Bleeding Disorders Awareness Month in the State of California. Specifically, **this resolution** makes the following legislative findings:

- 1) Hemophilia is a rare genetic condition affecting at least 4,000 people in California and von Willebrand disease impacts at least 360,000 people in California.
- 2) Without treatment, people with hemophilia and other related bleeding disorders face frequent, spontaneous bleeding episodes in their joints, causing swelling in the joints, muscles, internal organs, and brain. Repeated bleeding episodes in the joints result in chronic degenerative arthritic conditions, which often lead to frequent hospitalizations, permanent disability, and chronic pain. Bleeding episodes involving internal organs and the brain can cause permanent damage, disability, and even death.
- 3) With proper care and access to comprehensive medical resources, persons with hemophilia and other related bleeding disorders can control bleeding episodes and can lead productive lives. Visits to federally recognized hemophilia treatment centers reduce morbidity and mortality significantly.
- 4) This awareness month will foster a greater sense of community and shared purpose among all individuals with inheritable bleeding disorders; and, elevate awareness of, and engagement in, the inheritable bleeding disorders journey beyond this community to the general public, enabling the prevention of illness, unnecessary procedures, and disability.
