Assembly Concurrent Resolution No. 72—Relative to American Stroke Month.

#### LEGISLATIVE COUNSEL'S DIGEST

ACR 72, as introduced, Gipson. American Stroke Month.

This measure would declare May 2015 to be American Stroke Month in California, and would urge all Californians to familiarize themselves with the risk factors associated with stroke, to recognize the warning signs and symptoms of stroke, and, at the first signs of a stroke, to dial 9-1-1 immediately in order to begin to reduce the devastating effects of strokes on our population.

1 WHEREAS, Stroke is a leading cause of serious long-term

2 disability and the fifth leading cause of death in the United States,

3 killing approximately 130,000 people nationwide and over 13,500

4 citizens of California each year; and

5 WHEREAS, Between 2012 and 2030, total annual direct 6 stroke-related medical costs are expected to increase from \$71.55

7 billion to \$184.13 billion, and overall, total annual costs of stroke

8 are projected to increase to \$240.67 billion by 2030, an increase

9 of 129 percent; and

10 WHEREAS, Nearly 80 million Americans have high blood

11 pressure, a major controllable risk factor for stroke, including 44

1 percent of African American adults, which is among the highest

2 prevalence of any population in the world; and

WHEREAS, More than one-half, or 58 percent, of Americansdo not know if they are at risk for stroke; and

5 WHEREAS, One in three Americans cannot recall any stroke 6 warning signs or symptoms; and

7 WHEREAS, The F.A.S.T. warning signs and symptoms of 8 stroke include face drooping, arm weakness, speech difficulty and 9 time to call 9-1-1. Beyond F.A.S.T., additional stroke warning 10 signs and symptoms include sudden numbness or weakness of the face, arm or leg, especially on one side of the body, sudden 11 12 confusion, trouble speaking or understanding, sudden trouble 13 seeing in one or both eyes, sudden trouble walking, dizziness, loss 14 of balance or coordination, and sudden severe headache with no 15 known cause; and 16 WHEREAS, On the American Stroke Month Day of Action 17 May 1, 2015, throughout May and year-round, the American Stroke 18 Association's "Together to End Stroke" initiative encourages

Americans to learn their personal stroke risk, memorize and share the stroke warning signs, and call 9-1-1 at the first sign of a stroke;

Alzheimer's disease. progressive а 2 neurodegenerative brain disorder, tragically robs individuals of 3 their memories and leads to mental and physical impairments; and 4 WHEREAS, This condition has become the fifth leading cause 5 of death in California as numbers have increased by 169 percent 6 since 2000; and 7 WHEREAS, An estimated 5.1 million Americans 65 years of 8 age and older have Alzheimer's disease, and another 200,000 9 people under 65 years of age have younger-onset Alzheimer's 10 disease; and WHEREAS, Deaths from other major causes have decreased 11 12 significantly, official records indicate that deaths from Alzheimer's 13 disease have increased significantly; and WHEREAS, In 2014, friends and family of people with 14 15 Alzheimer's disease and other dementias provided an estimated 17.9 billion hours of unpaid care, a contribution to the nation 16 17 valued at \$217.7 billion; and 18 WHEREAS, In 2015, the direct cost to American society of 19 caring for those with Alzheimer's disease will total an estimated 20 \$226 billion, with one-half of the costs borne by Medicare, and an 21 expected growth of \$1.1 trillion by the year 2050; and 22 WHEREAS, There is currently no way to prevent, cure, or even 23 slow down the progression of Alzheimer's disease; and WHEREAS, Researchers in California and around the world 24 25 continue their efforts to develop scientific breakthroughs that could 26 one day bring about a world without Alzheimer's disease; and 27 WHEREAS, In recognition of the individuals, families, friends, 28 and caregivers dealing with Alzheimer's disease; and the 29 researchers who are seeking a cause or cure; and 30 WHEREAS, In recognition of the efforts of the Alzheimer's 31 Association to raise funds and promote awareness to fight 32 Alzheimer's disease and other dementias, thereby improving the 33 quality of human life for people living with Alzheimer's disease 34 and their caregivers; now, therefore, be it 35 Resolved by the Assembly of the State of California, the Senate thereof concurring, That the Legislature of the State of California 36 37 recognizes the month of June as Alzheimer's and Brain Awareness 38 Month, and recognizes June 21, 2015, as The Longest Day in 39 California and urges all residents to wear purple on this day to 40 help spread global awareness of the Alzheimer's Association's

- 3) In 2015, the direct cost to Americans of caring for those with Alzheimer's disease will total an estimated \$226 billion, with one-half of the costs being paid by Medicare, and an expected growth of \$1.1 trillion by the year 2050.
- 4) There is currently no way to prevent, cure, or slow down the progression of Alzheimer's disease and researchers in California and around the world continue their efforts to develop scientific breakthroughs that could one day bring about a world without Alzheimer's disease.

Assembly Concurrent Resolution No. 81—Relative to Philippine Independence Day.

#### LEGISLATIVE COUNSEL'S DIGEST

ACR 81, as introduced, Chiu. Philippine Independence Day.

This measure would recognize June 12, 2015, as the 117th Anniversary of Philippine Independence and would call upon the people of the state to observe the month of June with appropriate ceremonies, programs, and activities.

Fiscal committee: no.

1 WHEREAS, On June 12, 2015, the Filipino American 2 community will celebrate the 117th Anniversary of Philippine 3 Independence, and on this occasion it is appropriate to make special recognition of California's Filipino American citizens and thank 4 5 them for their countless contributions to our nation's cultural, economic, and political heritage; and 6 WHEREAS, The Philippine Declaration of Independence took 7 place on June 12, 1898, in the town of Cavite El Viejo, now known 8 9 as Kawit, located in the Philippine province of Cavite, when Filipino revolutionary forces, under the leadership of General 10

11 Emilio Aguinaldo, publicly read the Act of Declaration of 12 Independence proclaiming the sovereignty and independence of

13 the Philippine Islands from the colonial rule of Spain, after

1 American and Filipino revolutionary forces defeated Spain at the

2 Battle of Manila Bay during the Spanish-American War; and

3 WHEREAS, The declaration was not recognized by the United

4 States or Spain. Spain later ceded the Philippines to the United

5 States in the 1898 Treaty of Paris that ended the Spanish-American

6 War. The United States government did not recognize Philippine 7 independence until the signing of the Treaty of Manila on July 4,

8 1946; and

9 WHEREAS, For nearly two decades, July 4 was observed in 10 the Philippines as Independence Day until President Diosdado 11 Macapagal, upon the advice of historians and the urging of 12 nationalists, signed the Republic Act No. 4166 into law on August

13 4, 1964, designating the country's Independence Day as June 12.

14 June 12 was previously observed as Flag Day and on that day many

15 government buildings were urged to display the Philippine flag in 16 their offices; and

16 their offices; and

17 WHEREAS, As the years went on, Filipino Americans became

18 very involved in the community and made numerous contributions

19 in all aspects of American society and culture, especially in

20 California; and

WHEREAS, Many people of Filipino descent have contributed
to great movements that have helped to shape our country and its
role in the world, including the late Larry Dulay Itliong, labor

organizer and the first vice president of the United Farm Workers

25 Union, the late Philip Vera Cruz, cofounder of the United Farm

26 Workers Union, and the late Carlos Bulosan, one of the first

27 Filipino-American novelists to gain fame for his work; and

28 WHEREAS, Many Filipino Americans have served with 29 distinction as outstanding soldiers who fought as members of the

30 United States Armed Forces for over a century and have sacrificed

31 their lives in many wars, including World War II; and

32 WHEREAS, Today there are more than 3.5 million people of

33 Filipino American descent, many of whom have played vital roles

34 in the development of the United States and have paved the way

35 for Filipino Americans to continue to strengthen their roles in the

36 broader society and to contribute to American and California

37 politics, economy, and culture; now, therefore, be it

38 *Resolved by the Assembly of the State of California, the Senate* 

39 thereof concurring, That the Legislature, in honor of the multitude

40 of contributions that Filipino Americans have made to make this

1 a better country and state for all people, recognizes June 12, 2015,

- General Emilio Aguinaldo read the Act of Declaration of Independence on June 12, 1898, proclaiming the sovereignty and independence of the Philippine Islands from Spain, after United States and Filipino revolutionary forces defeated Spain at the Battle of Manila Bay during the Spanish-American War.
- 2) The declaration was not recognized by the United States or Spain until the signing of the Treaty of Manila on July 4, 1946; and, for nearly two decades, July 4 was observed in the Philippines as Independence Day until President Diosado Macapagal signed the Republic Act No. 4166 designating the country's Independence Day as June 12.
- 3) As years went on, Filipino-Americans became very involved in the community and made numerous contributions in all aspects of American society and culture, especially in California; and, many Filipino-Americans have served with distinction in the United States Armed Forces for over a century and have sacrificed their lives in many wars, including World War II.

16	WHEREAS, To do so, residents of this state will need to acquire

18	wildfire and to take action before the wildfire occurs; and
19	WHEREAS, The educational tools for preventing wildfires and
20	protecting against them when they occur already exist; and
21	WHEREAS, It is essential that we reach out to our communities

23	with knowledge, residents of this state can learn to live safely in
